# **Club Regulations**

## Territorial Boundaries:

### Georgia

### Mission:

Creating unique environment for establishment and expansion of business relations, and exchanging information among business representatives.

## Goal:

Encourage and support high ideals of entrepreneurship, in particular:

- 1. Development of personal contacts, as an additional opportunity for a successful business;
- 2. Establishing high ethical principles in business and professional fields;
- 3. Establishing international understanding, goodwill, peace, global partnership among the businessmen, who are ready to serve the public ;

### Privileges:

- Possibility of establishing relationship with people with common ideals and values;
- Exclusive opportunity to attend the programs organized by the club;
- The possibility of establishing relations with members of the International Forbes Club;
- The possibility of expanding the boundaries of business and partnership;
- The opportunity of getting discounts and privileges obtained by the club.

### Candidates for membership:

People with a positive business and professional reputation, managers and owners of large and mediumsized businesses, cultural figures, Georgian and foreign politicians, diplomats, as well as the representatives of science and art engaged in entrepreneurial activities.

### Membership Types:

There are 2 types of membership:

- 1. Acting members persons engaged in entrepreneurial activity
- 2. Honorary members persons of great merit who greatly contributed to the development of business, culture, science, art and other sectors, and who have stopped their business and professional activities, as well as Georgian citizens working abroad, who are not able to attend the club meetings regularly.

### Membership Conditions:

Letter of Invitation from the Club is required to become a member.

Joining the club also is possible based on letter of recommendation from acting members. Forbes board of directors makes decision on enrollment of new members.

#### Meetings:

Club meetings are convened on a monthly basis at specified time and location. In exceptional cases (field meetings, sound reason), time and location of the meeting can be changed. Meetings can be cancelled due to official holidays or force majeure circumstances. Meetings can be cancelled also due to any other sound reasons that are not specified above. Besides, cancellation twice in a row is not allowed.

#### Membership Fees:

Annual membership fee for acting members (nominal payment) is GEL150. Membership fee should be paid twice a year in equal installments on 15 March and 15 June. In addition, You will receive a new copy of Forbes each month during a year. Honorary members of the Club are exempt from membership fee.

### **Obligations of Club Members**:

Attendance at the Club meetings by acting members is mandatory. Members, not attending 4 consecutive meetings (except for good reasons) will be automatically dismissed.

Selection and recommending new worthy persons for membership is a privilege and obligation of any Club members.

Club members shall not disclose any information or materials obtained at the close meetings.

#### Informing Club Members and Public:

Club management assumes obligations to provide club members with detailed information concerning the agenda of the meetings and arrangements.
